You'll help save lives

Professor Ian Frazer's work on an HPV vaccine to prevent cervical cancer is an example of how gifts to Cancer Council Queensland directly contribute to major breakthroughs.

In 2005, Professor Ian Frazer and his colleague announced they had created a vaccine to prevent the type of human papilloma virus (HPV) that causes cervical cancer. It was the world's first cancer vaccine. Since then, the national vaccination of teenage girls and boys has meant that cervical cancer rates have dropped significantly in Australia.

The breakthrough, which was partly funded by legacy gifts to Cancer Council Queensland, promises to protect future generations from cervical cancer in Australia and around the world.

By including a gift in your Will to Cancer Council Queensland, you're ensuring that cancer research projects can be undertaken using cutting edge technologies, and with the certainty of ongoing funding.

Our 13 11 20 Information and Support Service is here for all Queenslanders affected by cancer, at every stage of diagnosis

Cancer counselling

Our specially trained nurse counsellors and psychologists support Queenslanders impacted by cancer.

Accommodation

Our Support Hubs in Cairns, Townsville, Rockhampton, Brisbane, and Toowoomba provide a welcoming home away from home for those who need to travel to access treatment – particularly those in regional and remote areas.

Transport to Treatment

When Queenslanders need support getting to and from hospital or treatment facilities, we offer a range of transport services at no cost.

Wigs & Headwear

We provide wigs and other items of headwear to Queenslanders experiencing hair loss because of their treatment.

Garth & Kay's story

Garth and Kay Stephens made the decision include gifts in their Wills to Cancer Council Queensland after Garth's father passed away due to cancer.

"That's when we decided, let's put something in. We updated our Wills and decided to formalise the gift," says Kay.

Garth acts as a peer support volunteer for people living with cancer, and Kay runs Australia's Biggest Morning Teas to raise funds. "Everyone is touched by cancer," Kay says. "Every family has a cancer story."

Garth says: "Mum had cancer, Dad had cancer, Kay's father had cancer, and I've had cancer."

"I see Cancer Council Queensland really trying to get to people with cancer to help them live a good life, even if it's terminal cancer. There are solutions around. And people don't always know what's available to them."

Your questions answered

Do I have to be wealthy?

Anyone can include a gift of any amount in their Will. You don't have to be wealthy. Of course, please consider your family and loved ones first.

Every donation helps with research, preventing cancer and supporting Queenslanders going through cancer and their families.

What types of gifts can you leave in your Will?

There are several different ways to include a gift in your Will.

A residual gift

By including a "residual gift" to Cancer Council Queensland you are telling your executor that, once any debts are paid and specific gifts are distributed to the loved ones named in your Will, the remainder (or a proportion of the remainder) of your estate will be gifted to Cancer Council Queensland.

A fixed specific gift

This involves gifting an asset such as real estate, shares, vehicles or specific items.

A fixed sum of money

Also known as a pecuniary bequest, this involves gifting a specific dollar amount. Your solicitor can advise you of ways to ensure the gift retains its relative value (for example, by increasing the amount by reference to CPI)

Whole or part of your estate

You can include your whole estate or any part of your estate to Cancer Council Queensland.



Why would I allocate my gift to “general charitable purposes” rather than something specific like research?

Most people choose to include a gift in their Will for “general charitable purposes”. Our research, prevention programs and support services here at Cancer Council Queensland continue to grow and evolve over time, and the more flexibility we have to carefully direct your bequest in the best way possible, the better equipped we are to meet the needs of Queenslanders.

Some people do choose to direct their gift to a particular type of cancer or area of personal interest, perhaps because of their own experience with cancer or in tribute to a loved one lost to cancer. These gifts are more than welcome, and we would be honoured to fulfill your wishes.

Do I need a solicitor?

We strongly suggest you talk to a solicitor to help write or update your Will. Some people write their own Wills using kits online or bought from a newsagency or post office. However, in order for a Will to be valid, there are certain legal requirements that need to be met, and working with a solicitor will help ensure that everything's done correctly

Solicitors charge different amounts to write Wills, so do some research to make sure you get the best deal.

Cancer Council Queensland's Free Will Service is available to anybody who needs a basic Will written or updated and kindly includes a gift in their Will.

Is there a simple way to change my existing Will?

If you already have a Will, the most cost-effective way to include a gift to Cancer Council Queensland is by adding a codicil, which is a short legal amendment to your Will. Check with your solicitor if a codicil is appropriate for the updates you wish to make. Adding a codicil could be done via a simple email exchange with your solicitor, and then popping into their office to sign the amendment. This can also be done through our Free Will Service.

Avril's story

Avril, a retired cattle farmer in her eighties, has lived in Goondiwindi in Queensland's Darling Downs for more than half her life.

A deeply compassionate person, Avril volunteers at her local Driver Reviver site and delivers food for Meals on Wheels. She has also donated regularly to Cancer Council Queensland since 1992 yet refuses to take credit for her incredible contribution of over more than twenty years.

Avril says, "At the time, my husband and I just decided we should start supporting something we may need, and other people do need."

She has very kindly included a gift to Cancer Council Queensland in her Will.

Avril says, "I can't help physically but I can donate. So that's what I did."

"You've got to target the areas you think are most important in your own life. I know a lot of people who have gone through cancer."





Information for solicitors

Information for the solicitors of people who wish to include a gift in their Will to Cancer Council Queensland.

At Cancer Council Queensland, we believe that family comes first. We would encourage you to recommend that your client discuss their intentions with their family members. Please encourage your client to contact us so we can acknowledge their gift by inviting them to join as the Daffodil Circle (see page 22).

Please also pass on Cancer Council Queensland's sincere thanks for choosing to support our work in this way. Gifts in Wills are a significant source of funding for the work of Cancer Council Queensland and we are incredibly grateful for each and every gift.

When you see your solicitor about making or amending your Will, you might find it useful to give them this information.

This is the suggested wording to include a gift in a Will to Cancer Council Queensland (ABN 48 321 126 727). Please select the wording that best reflects the kind of gift your client wishes to give.

Residual gift

"I give, devise and bequeath [insert either the fraction or percentage of your residuary Estate you would like to give, or the wording "all of my residuary estate"] to Cancer Council Queensland presently of 553 Gregory Terrace Fortitude Valley, Queensland to be applied for [insert either "its general charitable purposes" or the specific purpose you would like the gift to be used for.]

Specific or monetary gift

"I give and bequeath [insert either the particulars of the specific item being given, or the sum of money being given] to Cancer Council Queensland presently of 553 Gregory Terrace Fortitude Valley, Queensland to

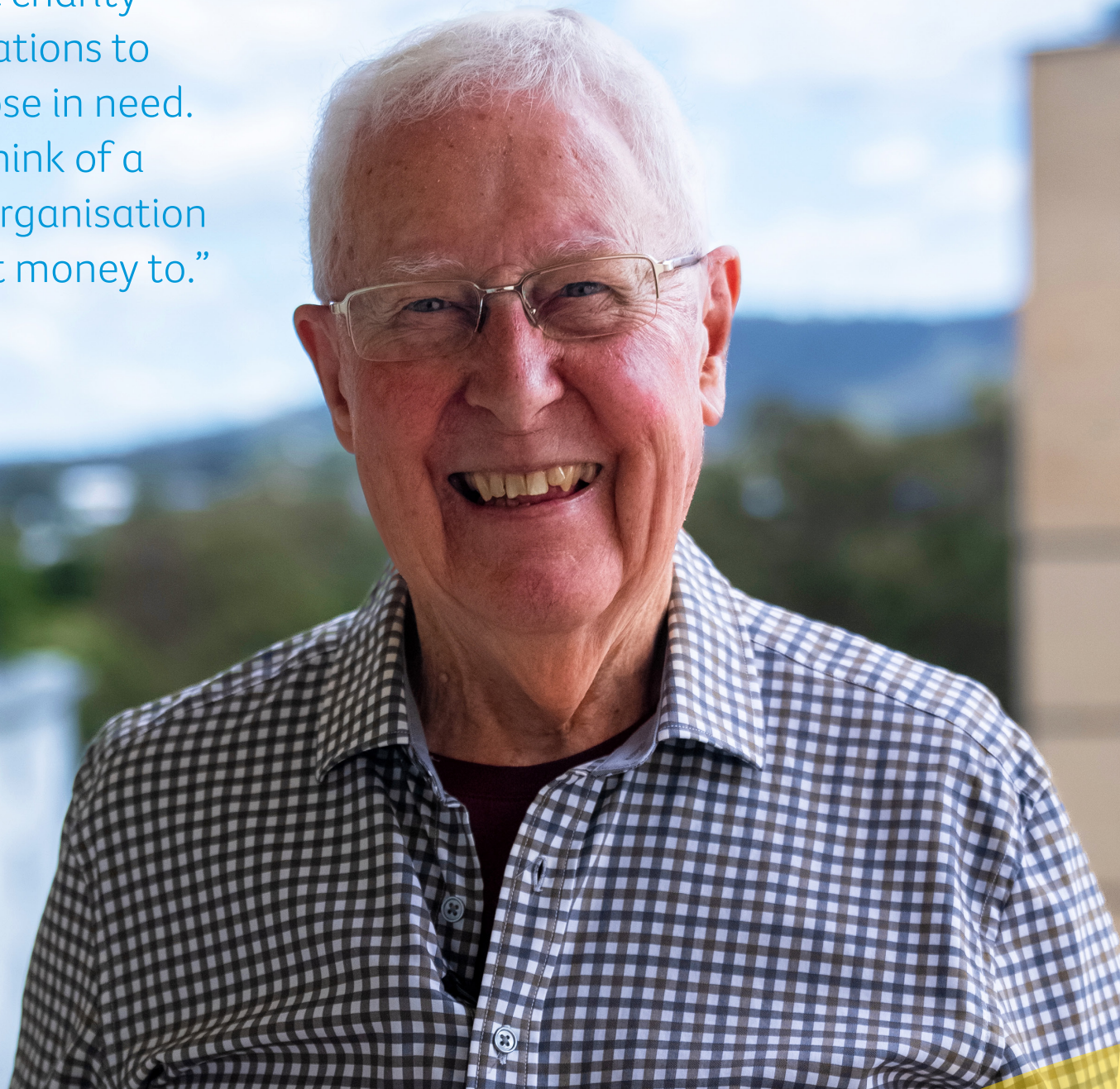
be applied for [insert either "its general charitable purposes" or the specific purpose you would like the gift to be used for.]

Declaration:

When you make a gift in your Will to Cancer Council Queensland, your Will should also include the words:

"In relation to that gift, I declare that a general charitable intent applies, a receipt signed by a person authorised by Cancer Council Queensland shall constitute a full and sufficient discharge to my Executors and my Executors are not obliged to see or enquire into the application of the subject matter of the gift made by me."

Alan’s story

After Alan Galwey retired in 1991, he started volunteering with Cancer Council Queensland.

“So many people are affected by cancer, whether it’s themselves or a loved one. It’s a dreadful disease and there’s no doubt Cancer Council Queensland are making great inroads into research, but obviously there is a long way to go. Cancer research is vital because the sooner we can get a breakthrough, the better things will be,” said Alan.

Alan is one of many Queenslanders who have used our Free Will Service, which is available to anyone who needs a basic Will written or updated, and kindly includes a gift in their Will to Cancer Council Queensland.

Alan said “I’ve certainly left money to my nieces and nephews and to some very close friends, but I can’t think of anything better than to leave some money to Cancer Council Queensland. I just hope that work continues.”
